

**ORDINANCE NUMBER: 2024-03**

**ORDINANCE PROVIDING FOR BUDGET AND APPROPRIATIONS OF RIVER GROVE PUBLIC LIBRARY DISTRICT, COOK COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 2024 AND ENDING JUNE 30, 2025**

WHEREAS, the Board of Library Trustees of the River Grove Public Library District, Cook County, Illinois, caused to be prepared in tentative form, a Budget and Appropriation Ordinance, and the Secretary of the Board has made conveniently available to the public inspection for the last thirty (30) days prior to final action thereon: and

WHEREAS, a public hearing was held as to such Budget and Appropriation Ordinance on July 10, 2024, and a notice of said hearing was given at least thirty (30) days prior thereto, as required by law, and all other legal requirements have been complied with;

NOW, THEREFORE, be it ordained by the Board of Trustees of said District as follows:

Section 1: That the fiscal year of this Public Library District is hereby fixed to begin July 1, 2024 and end on June 30, 2025

Section 2: That the following Budget and Appropriations containing an estimate of the amounts available and expenditures be and the same are hereby adopted as the budget and amounts appropriated of this Library District for the said fiscal year.

The foregoing appropriation is hereby appropriated from the proceeds of a special tax for participation in the Illinois Municipal Retirement Fund expense purposes and is in addition to all other library district taxes as provided by law.

ESTIMATED EXPENDITURES - SOCIAL SECURITY FUND

Social Security/FICA \$42,000.00

The foregoing appropriation is hereby appropriated from the proceeds of a special tax for Social Security/FICA expense purposes and is in addition to all other library district taxes as provided by law.

**PART VII**

ESTIMATED EXPENDITURES - UNEMPLOYMENT COMPENSATION FUND

Unemployment Compensation \$3,000.00

The foregoing appropriation is hereby appropriated from the proceeds of a special tax for unemployment compensation expense purposes and is in addition to all other library district taxes as provided by law.

**PART VIII**

ESTIMATED EXPENDITURES - WORKERS COMPENSATION FUND

Workers Compensation \$4,000.00

The foregoing appropriation is hereby appropriated from the proceeds of a special tax for workers compensation insurance expense purposes and is in addition to all other library district taxes as provided by law.

**PART IX**

ESTIMATED EXPENDITURES - WORKING CASH FUND

Working Cash Fund \$123,750.00

The foregoing appropriation is hereby appropriated from the proceeds of a special tax for working cash purposes and is in addition to all other library district taxes as provided by law.

**PART IX**

ESTIMATED EXPENDITURES - BUILDING/SITE FUND

Building/Site \$48,000.00

The foregoing appropriation is hereby appropriated from the proceeds of a special tax for building/site expense for the purpose of purchase, construction, and maintenance of sites and building, equipment, and maintenance, repairs and alterations of library buildings and equipment and is in addition to all other library district taxes as provided by law.
